A Sun Life Assurance Company of Canada, policy number unknown, in the amount of \$1,000.00 - in the owner's possession.

As the above did not come under the control of the Custodian no action was taken.

The Custodian received a refund of \$4.50 from the Provincial Collector, Vancouver, being a refund of 1% of his wage deductions for the first six months of 1941. This amount was forwarded to Kaoru KOBAYASHI on December 1, 1943.
