These files may now be regarded as closed. The husband declared a bed, dresser and two chairs left at Wilson Creek and Mr. R. F. Brown on his visit there, found also a trunk and new Singer sewing machine. The wife did not declare anything but later asked for the sewing machine and trunk to be sent to her. These were evidently received as well as subsequently the bedroom suite asked for. If anything is left at Wilson Creek it can be of no value and will, in any case, be looked after by the Burns and Jackson Logging Company as per their letter of May 9th, 1942.
