
To the File

According to the file of the above Japanese no liabilities are filed against him, nor are any filed against his wife.

The only assets which he declared were, a five dollar War Savings Certificate which was not brought under control by the Custodian and a quantity of household chattels said to be left at 2365 West Broadway. He makes note that these chattels may have been registered by his wife. They were registered by his wife on File No. 5542, and the administration of same was carried on by this office under her account. From her file it is apparent that the chattels were moved subsequent to the registration of the above Japanese, to Mission, where they were stored with his wife's family, and are well accounted for on her file.

No further administration is necessary on this file and it can therefore be closed.
