Re: OIKAWA Naka #08631-YOUR FILE #1642. Dear Sir: The above Japanese who lived at Fraser Mills, was living on land owned by the Mill. By arrangement with the Mill the Japanese were allowed to building themselves houses on Mill property, the house to be the property of the Mill when the Japanese left the Mill. The rent for the land was \$9.00 per month including light, water and wood. The furniture on attached list was stored in the United Church Mission School at 325 Ewen Avenue New Westminster. I am informed that Mr. Olkawa sold some of his furniture and also took some away with him which accounts for the discrepancy in the list with this J.P.Form. I am informed on reliable author-ity that there was nothing left in the house when he was evacuated. To whom he sold his furniture I was unable to find out. I am attaching expense sheet on this case as I consider the case closed as far as we are concerned, he having no real estate to look after.

Trusting you will find this satisfactory.
