This man signed a declaration to the Gustodian on April 7, 1942. He was evacuated on April 21, 1942.

In his declaration he reported 24 packages of household goods at the C.P.R. Wherf, Vancouver. These were released to him on March 23, 1942.

He reported 4 packages of household goods at 467 Powell St., Vancouver. These were shipped to him on October 30, 1942.

He reported personal effects in his own possession, at Hastings Park. We assume he took these with him on his evacuation.

He reported \$48.00 in War Savings Certificates in his own possession and a \$2,000.00 policy with the Sun Life Assurance Co. in his own possession. These items did not come under the control of this office.

P. S. Ross & Sons notified us on August 30, 1943 that this man had a credit balance with the Manaimo Shipyards Ltd. of \$56.73. However the assets of this company have not yet been disbursed and we are therefore holding this file open awaiting receipt of this amount.

This file reveals no other property of any kind.
