OTAMA made his declaration to the Custodian on April 7/42 and was evacuated on Sept. 12/42. He declared the following at 566 E. Cordova St. in his own possession:

personal effects text books violin carpenter's tools

We wrote to him on Oct. 24/42 asking him if he had left any of his possession in the protected area. We received no reply to this letter so it may be assumed he took the personal effects declared with him at the time of his evacuation.

He declared a debt owing to Dr. Seldon. We wrote him regarding this debt and on May 1/44 he replied advising that he was writing to Dr. Seldon regarding same. We had a phone call from Dr. Seldon's office stating that they had heard from OYAMA and that he had suggested some sort of settlement. We advised them of the full name and address of OYAMA and requested they deal with him direct regarding settlement of this claim.

The above summary is certified to be in accordance with the information on file.
