Referring to your letter of November 10th. we have made a check of the chattels stored in the basement of 1011 Royal Avenue and find that there are a great many articles so mixed up together and packed in so tightly and in such confusion that is is impossible to make a check unless they are all moved out. After this is done they might as well be moved to storage at one of our depots.

Mone of these articles are tagged so we do not know who are the owners and it is quite possible that they belong to the above mentioned parties. In the list which you have been kind enough to send us there are three sewing machines. We can find no trace of these and on the other hand there are three gramaphones there which are not on the list.

It appears that the only satisfactory way would be to write to these people and find out if their belongings are stored here and then have them moved by a furniture moving company when a proper inventory could be made. We will await your instructions in this matter.

This declarant stated that he left at 1011 Royal Ave. New Westminster, a dinting room table, and four chairs, bedroom suite, writing desk, table lamp, chinaware, silverware, two lineleums. Our agents in New Westminster, Coulthard & Sutherland, stated on Movember 18, 1942 that chattels belonging to Your Jupines. Japanese were in the basement of this place and so mixed up and in such confusion that they could not be licentified. Mamoru NISHI was requested on November 24, 1942 to state whether he actually left and effects of his at 1011 Royal Ave. and his reply to this and other requests along the same lines were so evasive that it may be assumed that NISHI made his own disc

The file reveals Mamoru NISHI, prior to his evacuation, carried \$500.00 fire insurance on his nousehold effects located at 209 #3 Road, Eburne, and although he was asked on March 29, 1944 if he wished the coverage transferred to IMIL Royal Ave.he did not raply. He did however state that there were no effects of his at #3 Road, Eburne.

When the chattels were removed from the basement at 1011 Royal Ave. nothing could be identified as belonging to Mr. NISHI, although some effects were identified as belonging to his wife, Hanae, who also declared effects (file 10378).
