GENERAL SUMMARY

File 1839

Re: TANAKA, Zenichi,

Zenichi TANAKA, confectioner, signed his Declaration to the Custodian on April 8, 1942. He was evacuated on June 8, 1942. He lived at 2006 West 4th Ave., which was owned by his father, Masuya TANAKA, File 3326. The grocery business was sold by Masuya TANAKA before his evacuation.

On April 8, 1942, Zenichi TANAKA declared a Chevrolet Sedan car in police custody. A memo of April 1, 1943, states that proceeds from sale of car had been mistakenly credited to George Joji TANAKA, File #919, which accounts for the fact that the net amount of \$424.77 from the sale of the car was not credited to Zenichi TANAKA's account until September 3, 1943. On November 16, 1943, we sent TANAKA a general explanation of why cars were sold. (On November 23, 1947, we sent him a cheque for \$424.77, proceeds from sale of car.) *Address unknown - requested of father
sent him by mail - 1/2 cc. H.A.*

TANAKA also declared one Victor Radio (combination) in custody of police. A radio, reported to be his, was sold at Vancouver Auction 37, December 15, 1944 for the net amount of \$8.53. (On November 25, 1947, we asked him to send us the receipt he holds for his radio so we could send him the proceeds from sale of same.) *Same as above.*

TANAKA declared a joint Life Insurance policy for \$2,000.00, Crown Life Insurance, with his wife. It was left in his father's possession. There is no mention of this policy on his father's file 3326, Masuya TANAKA, nor on his wife's file 11001, Shizuye TANAKA. No action was taken by the Custodian with regard to this policy.

This file reveals no other personal property of any kind.

No liabilities are revealed on this file or on that of his wife, Shizuye TANAKA, File 11001.
