Dear Sir:

In reply to yours of August 11 regarding a small boat left at Ocean Falls and of an outboard motor taken into custody by Naval Serikae, I regret to say that I have not the serial number of the motor.

Since my boat and motor were taken away on so short a notice. I forgot to take down the serial number of the motor but since I bought it at the Ocean Falls General Store in either 1936 or 1937, I wonder if I could not ask you to write to Mr. Campbell of the Hardware Department of the store. I will write too, and will send you the serial number as soon as possible.

Our boat was a Columbia, about 18 feet in length. I believe it was painted white on the outside and green inside, but since I changed the colour every year, I cannot remember exactly what I had painted it last. At any rate, the name SEXI is carved on the inside of the boat.

I am definitely the M. Seki concerned.

I am sorry that due to my carelessness, I have caused you so much trouble. I hope that the above has assisted you even in the least.
