> The above declared a life insurance policy with the Sun Life Assurance Company in the sum of \$1500.00. While he was at Petawawa Internment Camp he declared a policy in the Sun Life Assurance Co. for \$2000.00. Upon enquiry from the Sun Life Company we were advised that the above had a policy for \$2000.00 with their company. In a letter dated Oct. 6/43 the above asks us to send this policy to him We informed him on Nov. 343 that this policy was not in our possession. This policy did not come under the control of the Custodian. see letter of november 19/46 re chique for carlsungle
