PERSONAL PROPERTY SUMMARY

CHATELS:

The above, who made his declaration to the Custodian on April 8/42 and was interned on April 29/42, declared no chattels and none were subsequently found belonging to him.

SPECIFIED ARTICLES:

A radio surrendered by the above to the R.C.M.P. on March 10/42 was handed over by them to the Custodian and sold at auction on May 2/44 for the net sum of \$19.05, and this sum credited to the account of the above with the Custodian.

WAR SAVINGS CERTIFICATES:

Two War Savings Certificates surrendered by the above to the authorities at Petawawa Internment Camp were remitted by them to this office on June 15/42 and were put in envelope No. 114 in our safety deposit box. These are being remitted to the above along with a cheque for his credit balance with this office in the course of the next few days.

LIFE INSURANCE:

The above declared a life insurance policy with the Sun Life Assurance Company in the sum of \$1500.00. While he was at Petawawa Internment Camp he declared a policy in the Sun Life Assurance Co. for \$2000.00. Upon enquiry from the Sun Life Company we were advised that the above had a policy for \$2000.00 with their company. In a letter dated Oct. 6/43 the above asks us to send this policy to him. We informed him on Nov. 3/43 that this policy was not in our possession. This policy did not come under the control of the Custodian.
