Kindly confirm this for I expect to do so for my Life Insurance Premium due next month payable to Crown Life Insurance Co.



I am in receipt of your letters of the 18th and the 20th with the cheque for \$4.80, being the refund of 1% wage deductions, for which I wish to thank you.

As stated in your letter of the 18th, I received my final salary from the N. S. McNeil Trading Co., Ltd., at the time I left, and also brought with me from my previous residence at 2292 Fast Hastings Street, Vancouver, what personal belongings I was allowed to carry, leaving behind nothing that I need to claim for now. I am in possession of the Victory Bonds and the War Savings Certificates referred to and so believe, aside from the bank account which I intend to transfer as soon as I am settled, I have nothing left behind on the coast.
