



Life Insurance: Mutual Life Insurance Policy No. 560959, 30 year endowment, in the amount of \$3,000.00, premium \$60.69, paid annually October 15.

Sun Life Assurance Company Policy 835946, in the amount of \$1,000.00, premium \$40.35, paid annually, June 15.

These policies did not come under the Custodian's control, and no premiums were paid through this office.

Radio: The radio, dealt with in Specified Articles Summary, was reported by the Royal Canadian Mounted Police. This was sold by the Custodian and the net proceeds of \$51.32 were credited to the account of Hideo MAEDA.
