PERSONAL PROPERTY SUMMARY

April 26, 1946.

Rev Tave (Mrs. Russo) MAGANO, Reg. No. 07440

This woman signed a declaration to the Custodian on April 8, 1946. She was evacuated on September 16, 1942.

In her declaration she reported 20 pieces stored at Port Alberni. On May 20, 1942, 15 pieces were shipped to Mrs. MAGANO at Hastings Park and 5 pieces were transferred to storage warehouse of No. Rurnip at Port Alberni, including a harber chair, looking glass, bed, couch and bed spring. The file shows the barber chair and looking glass were requested on June 30, 1942 and lacking evidence to the contrary we assume that these were shipped. File shows that the couch was discarded and the bed and spring were sold at anotion in January, 1944, and the net proceeds in the amount of \$12.80 were credited to the account of this woman.

This file reveals no other property of any kind.
