Replying to your letter of the 12th inst. regarding the above noted account.

Our list of Japanese Accounts receivable of April 30, 1942 included the name of T. Mitani showing a balance of \$93.93, Note \$79.75. This was meant to indicate that of the amount \$93.93 we held his note for \$79.75. It was not meant to infer that we we held a note for an additional \$79.75.

Regardinghis note in favour of Y. Yamaga. We hold one for \$27.43 which is dated Apl. 11, 1941. That has nothing to do with us. It is a private matter with Yamaga.

Apparently Mitaniconsiders that account paid when he gave a note. His claim to having 111 shares is correct, but we have not authority to cancel shares for debt. Almost all balances owing by Japanese could be cleared by the cancellation of shares owned. The Go-operative Associations Act empowers us to do so; but an order, dated Sept. 4, 1942, from the Custodian, directed that we should not make any change in the Capital set-up without his permission. We have sought permission on two occasions without success. If we could do so it would be to our mutal benefit.
