did not arrive here until yesterday. Re the Hashimoto Family: they have
the use of a small building on my place situated on the Silverdale Rd at Mission.
This has been free of any charges. They have a lot of stuff stored there mostly
furniture and household effects. There was a couple of goats from the
Custodian's office in Mission some time in May or June last inspecting the
goods they had at that time an itemized list of the effects. I would refer you
to them. Please note that we do not assume any responsibility
whatsoever as to their safe keeping. I will leave that to the
Custodian he is getting paid for that we are not. Trust that
this clear and satisfactory
