MEMORANDUM: File 1960

January 9, 1945.

Re: Saichiro HIGO. Reg. 02023

B. C. Packers Ltd. hold a mortgage for \$9.31 on a vessel owned by this man.

However, this man did not declare ownership of a vessel, and we have no record of the sale of a boat belonging to him, or of the impounding of such a boat, therefore he must have sold his boat.

His son, Yukio HIGO?#02025, File 5328, sold two boats.

A vessel owned by an "S. Higo" was given Naval Control No. NW.028E. This number was carried by a boat called "M.N." /"S.H.514", NW.2758, which was sold by S. Hayashi (JFVDC #345). The licence number, NW.2758, was issued to Sadakichi NISHI

CLAIMS SUMMARY

File No. 1960

August 17th, 1945.

RE: Seishiro HIGO

This file reveals that there were two claims lodged against the above, one in favor of the B. C. Electric Railway Co. in the sum of \$1.36, and the other in favour of the B.C.Packers in the sum of \$9.31, this being the amount owing for insurance on a boat they claimed was owned by the above Japanese.

On Nov. 24, 1943, Mr. McAllister wrote to Mr. Higo asking him if he owned a boat and asking for a description of it etc. He also advised him of the two claims against him. Mr. Higo replied in a letter dated Dec. 4th, 1943, saying he did not owe either of these amounts and that he did not and had never owned a boat. Mr. McAllister wrote on Dec. 21st, 1943, to the B.C.Packers Ltd. and gave them this information and advised them that we could do nothing further re the matter of their claim. He also wrote to the B.C.Electric Railway Co. and advised them likewise. Both companies were given Mr. Higo's address and advised that they could write direct to Mr. Higo and try and settle their claims with him personally. We also advised both of these creditors that the Mr. HIGO they had claims against might be Mr. Seiso HIGO, Reg. No. 08977, living at Turin, Alta.
