This Japanese had sold his property on agreement for sale to Mr. and Mrs. Broughton who were making monthly payments on the agreement and who will have paid in full for the property in the next three years.

They were enquiring about how this property could be conveyed if the Japanese were evacuated and the property under the control of the Custodian. I presume that in the event of Hoita's death or not being accessible the Custodian would have power to sign any documents on behalf of the Japanese. Will you be kind enough to let me know.

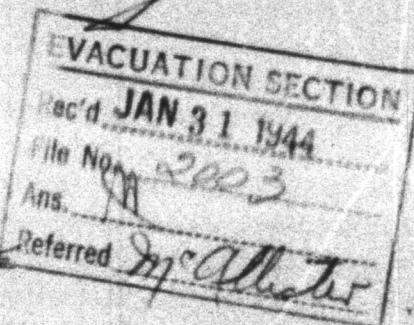
