This file reveals that UYESUGI owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATTELS:

UYESUGI made his declaration to the Custodian on April 10/42 and was evacuated on Sept. 12/42. We declared chattels as shown on Chattel Schedule on file. None were found by the Custodian at his home, 1017 W. 7th ave., and UYESUGI was advised of this. He did not reply to our letter regarding these chattels so it may be assumed he either took them with him or disposed of them prior to his evacuation.

In his letter of June 7/46 he declares a number of chattels left in care of Mr. R. T. Wilson, 4675 Connaught Drive. Mr. Wilson confirmed having these goods stored in his basement. We advised UYESUGI that he would have to arrange shipment of these goods himself as we did not have sufficient funds on hand to take care of shipping charges. We have heard nothing further from him on the matter, so it may be assumed he arranged this shipment with Mr. Wilson and that all these goods are therefore accounted for. There are no chattels on the file of his wife.

ACCOUNTS His account was credited with the sum of \$4.42, being a refund of 1% RECEIVABLE: wage deductions for the first six months of 1941. This was his only credit with the Custodian.

WAR SAVINGS He declared two \$5.00 War Savings Certificates in his own possession. CERTIFICATES: These were not brought under the control of the Custodian.
