PERSURAL PROPERTY SUMMARY

In his declaration to the Custodian on March 20, 1942, this man declared the following assets:

One \$100.00 Victory Bond and 12 \$4.00 War Savings Gertificates, in his own possession at the time of declaration. None of these came under the control of this office.

On May 23, 1942, this office sent to Shota UCHIKURA a cheque for \$2.17 representing income tax return from Provincial Government. The file reveals nothing further in regard to these funds, which look like a 15 wage deduction, but since this man and his family are the only persons named UCHIKURA in Custodian records, we must assume that the funds were handed to the person entitled to them.

The file of this man was credited with \$7.25 as refund of 1% wage deductions for the period January 1 to June 30, 1941, and these funds have been remitted to Shota UCHIKURA, less sum paid to M. Furuya Co. to pay debt.

In January, 1943, a heating stove was shipped to this man.

The radio surrendered by Shota UCHIKURA was sold by the Custodian for the net sum of \$30.92, which was credited to his account, and later remitted to him.

This file reveals no other property.
