GENERAL SUMMARY

July 4, 1946.

Re: Hideo UI, Reg. No. 10943

This man signed a declaration to the Custodian on March 24, 1942. He was evacuated on May 17, 1942.

In his declaration he reported a gas-boat "Florence U. No. 2". The records of the Japanese Fishing Vessels Disposal Committee show that this boat was sold and the net proceeds in the amount of \$393.50 were paid to UI on April 17, 1942.

He reported a \$50.00 War Savings Certificate and two \$5.00 War Savings Certificates in his own possession. These did not come under the control of this office, but our records show that in March, 1943 the redemption value of the three War Savings Certificates in the amount of \$48.51 was forwarded to UI through this office.

The account of this man was credited with the sum of \$5.00 as refund of expenses incurred at the time of the impounding of the "Florence U No. 2". This amount is being remitted to UI today.
