This man's name appears on the list of persons who have applied for repatriation to Japan. He is a Japanese National, at present residing at TASHME, B. C. There are no funds to his credit in the Custodian Trust Account.

In his declaration to the Custodian, March 21, 1942, he reported that he owned one \$5.00 War Savings Certificate and had an account with the Bank of Montreal, Duncan, in which there was, at that time, a balance of \$2.20.

A claim of \$10.00 was registered against this man, by P. S. Ross & Sons on behalf of Dr. C. G. HORI. YANAGIMOTO claims that he holds a receipt (in Japanese) signed by Jugiro HORI on behalf of Dr. HORI showing that this debt had been settled on March 5, 1942. This information was passed on to P. S. Ross & Sons, in February, 1944, and they were informed on May 15, 1944, that the Custodian would take no further action in regard to this claim.

Letter, January 16, 1946, from the Department of National Revenue shows a balance payable by YANAGIMOTO, on his 1943 Income Tax, of \$10.50. The Income Tax Statement shows that the refundable portion of his tax for that year (Enforced Savings) is \$97.00. The Department of National Revenue have been notified that this man has no credit balance with this office, and are being informed of YANAGIMOTO's present address.
