B.C. 11113 November 2, 1942 Mr. Harold Fern, King Edward Bay, Gibson's Landing, West Coast of Bowen Island, British Columbia. Dear Sir: On the record of Mr. Kingo Matsumoto and Mr. Kenichi Yamada, certain kitchen utensils, fish traps, etc., were left in the care of Mr. J.F. Malkin. We addressed Mr. Malkin on the subject of care and protection of this personal property and he called and informed us that as he was generally absent from Bowen Island, he suggested you might accept the care of the chattels left by the Japanese.
