
**SECURITIES:** 2 - \$5.00 War Saving Certificates, in owner's possession. These did not come under the control of the Custodian at any time.

**BANK ACCOUNT:** \$200.00 - Royal Bank of Canada. This did not come under the control of the Custodian.

**ACCOUNTS RECEIVABLE:** He loaned \$60.00 to his cousin, M. Rugen, New Westminster, B.C., according to JP Declaration. However, on July 9, 1943, Kurahashi wrote to this office informing us that this debt had been settled.
