CHATELS: The above declared household furniture left in a cannery house at Steveston (no number of house and no cannery named, although he worked for B. C. Packers). No chattels of any kind were found by the Custodian belonging to the above and we assume he either disposed of these prior to his evacuation or took them with him.

SPECIFIED ARTICLES: According to information supplied to this office the above was the registered owner of a fishing vessel the "Y.K." which was sold through the Japanese Fishing Vessels Disposal Committee for the net sum of \$492.50 and this sum was paid to KURAHASHI on April 7/42. Full details are given on Specified Articles Summary on file.

WAR SAVINGS CERTIFICATES: The above declared a \$5.00 War Savings Certificate in his own possession. This was not brought under the control of the Custodian.
