On December 18, 1944, the Gustodian sold at auction, the chairs, 2 barber's chairs, the mirrors, the cash register and the trunk and contents, together with a quantity of tools and kitchen utensils. The net proceeds of the sale amounted to \$39.51, which was credited to the account of Soseburo MAKASONE. This account had previously been debited with the sum of \$2.95 to cover expenses in sonnection with the sale of his effects, which made the actual net sum realized from the sale of his chattels \$30.56, which is the credit balance in his account.

On December 14, 1943, there were moved to the Willows, in addition to the articles sold at auction a year later, one wall clock and one metal hat rack. The file does not show the disposition.

The water heater and stove were not among the articles removed to the Willows, and the file reveals nothing further about these. It is possible that these may have been the property of the owner of the building in which NAKASONE's barber shop had been located. A carton of books are in Custodian Warehouse, Vancouver.

This file reveals no other personal or real property.
