We have the above-numbered Bond filed with the British Columbia Electric Railway Company Limited, guaranteeing the payment of four (4) years' minimum light charge, payable at the rate of \$2.30 per month.

This Bond became effective on August 8th, 1940, and therefore expires on August 8th, 1944, provided that the monthly charge has been paid. At the present time the balance on the Bond amounts to \$68.31.

As this party may be evacuated, we would ask you to be good enough to protect us for any balance which may become due by reason of the removal of Mr. Yamada, this to be paid from receipts which may come into your hands.
