DONDS & INVESTMENTS: The above Japanese registered with this office on the let May, 1942, and at that time, declared he had \$20.00 in Mar Savings Certificates, but these were not brought under control by the Gustedian.

Although he did not declare so, he was the holder of 18 non-redescentle charge in the Pacific Go-operative Union, and interest in the amount of 18s has been credited to his account from these shares from time to time totalling

MISHIERE also declared having a Life Insurance policy in the Morth American Life, and also a Crown Life Policy.

The Morth American Life remitted the following dividends on paid up premiums on his policy, through this office, and these were forwarded to HISHIZEKIS-

The Borth American Life and Grown Life advised us on the 15th September, 1946 and the 9th February, 1946, respectively, that HISHIERI had applied for the cash surrender value of his policies. However, as HISHIERI cond the hunkin Box Company the sum of \$50.00, he was advised that it would be necessary for him to suthorize payment of this account before the money could be remitted to him from this office. On the 26th February, 1946, suthomisation was received from both HISHIZEKI and his wife, Hismo HISHIZEKI, File No. 2251, as she was beneficiary under these policies, and payment of the Ruskin Box Company account was made in full 7th March, 1946. On the same date, the North American Life Insurance Company abeque of \$174.34, and the balance of the Crown Life Insurance Company abeque after payment of the claim (\$140.99 less \$50.00) - \$90.99 was forwarded to Mr. and Mrs. HISHIZEKI.

ACCOUNTS RECEIVABLE: The Provincial Government refunded the sum of \$4.32, being on his 1941 Provincial Income Tax.
