PERSONAL PROPERTY SUMMARY

Re: Meigi SATO - Regn. No. 06848

The above Japanese registered with this office on the 9th April, 1942, and was evacuated on the 11th April, 1942.

He declared no chattels or specified articles and none are revealed on his file.

BONDS & INVESTMENTS: SATO declared having a Victory bond but this was not brought under control by the Custodian.

ACCOUNTS RECEIVABLE: A refund of \$5.92 was forwarded to this office by the Provincial Income Tax Dept., being on his 1941 tax return, and at SATO's request was forwarded to him, 16th July, 1943.

SATO declared 18th Feb. 1943, that Tokue KAMEOKA owed him \$100.00. This sum was transferred in full 21st Aug. 1947, from KAMEOKA's account to Meigo SATO's account, and was forwarded to him by this office Nov. 10/47.

BANK ACCOUNT: SATO declared having an account at the Bank of Montreal, Main & Hastings Branch, Vancouver, but this was not brought under control by the Custodian.

He also declared an account with the Japan & Canada Trust Company of \$60.00. There is no account of this amount but there is 26¢ credited to an "M. SATO" which may possibly belong to the above named. He has been asked to forward his pass book to this office today. *(Not this Japanese, see list of 5th Jan. 1948.)*

LIFE INSURANCE: SATO declared several Life Insurance policies, but these were not brought under control or administered in any way by the Custodian.

This file reveals no other personal property assets.
