His belongings have all been moved to 604 East Cordova, ~~where~~ some shipment has been made subsequently -- see list dated April 20th, 1943.

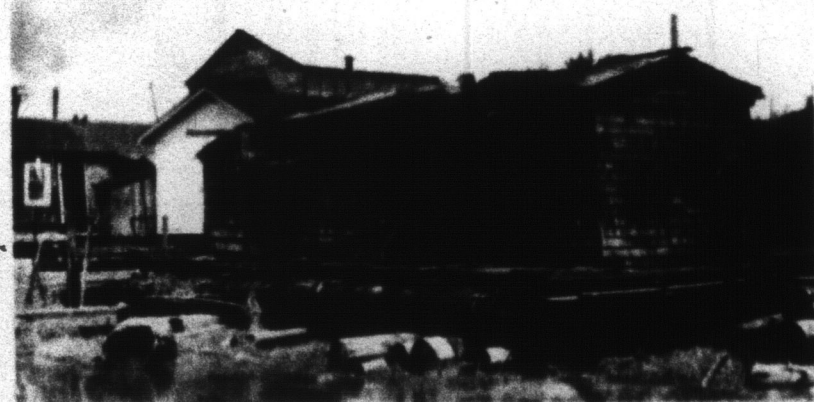

Thanks for the letter I received a few days ago. I will answer the question right here now. Yes, I lent the place to Mr. Maynard but did not know until recently that he had gone to the army. The man's name who owned the place was Mrs. Tokinazuke Uyeda. He told me that it would be better to have someone to look after the place so I got Mr. Maynard to stay & watch the place for us. I did not ask for any rent from him.

I sent a letter to Mr. Maynard about 2 months ago to send me my trunk in the front room but the letter returned to me for he wasn't at the address.

He has the key to the house but I have the key to the front room (the only room where all my belongings in it) and long for my trunk for I wish to have the personal belongings left in it.

I hope that some arrangements can be
made so that I can get my trunk if
I pay the freight expenses.
I do not wish for any of the other
things like bed etc but only my
trunk for I have my treasured things
in it.

Hope to hear from you soon on this
