Mrs. YODOGAWA declared on her J. P. form, dated April 9th, 1942, 1 stove and 1 Singer sewing machine. This person was evacuated on May 20th, 1942, and as these chattels were not in the Imperial Cannery House #34 at the time her husband's chattels were removed from there, we can only assume they were taken with Mrs. YODOGAWA at the time of her evacuation.

Mrs. YODOGAWA also declared one \$5.00 War Saving Certificate in her own possession which did not come under the control of the Custodian.
