Dear Sir: Mrs. Matsui, with whom you left your chattels, was to inform us when she was evacuated so that we could offer protection to your personal property. She did not inform us, but our investigators have discovered the following articles at your former address: 1 dining table 1 small table 1 chest-of-drawers 1 chair l armchair 3-pce. chesterfield set If this is correct, please sign and return the attached copy of this letter for our record. We assume that you have no other chattels remaining in the restricted area of British Columbia requiring our protection. Yours truly, Geo. B. Spain Protection Department GBS: NDE Bnc. 71 Oue.

Re: Mr. Hane OUE, Reg. No. 03161

This man signed a declaration to the Custodian on April 9th, 1942. He was evacuated on June 28th, 1942.

In his declaration he reported ownership of the chattels listed in the Chattel Schedule One of the items declared was a corner supposed or shelf. This article was found in Maikawa Stores Limited without identification and believed to be the property of that Company. It was sold. The net proceeds of this sale were received from P.S. Moss and Sons in the amount of \$25.00. This sum was remitted to Mr. OUE on August 10th, 1944, together with the sum of \$5.00 which he had sent to this office to cover shipping costs of this cupboard. The remainder of the chattels found and identified to be his property were sold for the net sum of \$9.26, which has been credited to his account.

Mr. OUE reported ownership of one \$100.00 Victory Bond, three \$5.00 War Savings Certificates, and \$2,000.00, approximately, on deposit at the Bank of Montreal, Main and Hastings. None of these items were brought under the control of the Custodian.

He reported one \$100.00 share in T. Maikawa Limited. No funds have been paid in to his account from the liquidation of that Company.

Mr. Shigeru OUE called at this office on June 5th, 1947, and stated that his father, Shigeyeshi OUE, who has been dealt with in our Enemy File 1508, and Hane OUE, are one and the same person. He said that his father's real name was Shigeyoshi but that he has used the name Hans and had been registered by the R.C.M.P. under that name. Shigeru OUE brought in a notice to Shareholders of Toric Mines Company Limited from the Liquidator of that Company which asked that shares be surrendered to the Liquidator, and he asked that the fives shares held in our safety deposit box be sent to the Liquidator of the Toric Wines Company Limited. The Share Certificate has been removed from the safety deposit box and forwarded to Mr. W. G. Nowe, Liquidator of the Toric Mines Company Limited, with the request that any funds due the Shareholder be sent to Mr. OUE at Vernon, B. C. We are cancelling Enemy File 1508 and transferring the papers to Evacuee File 2319.

The articles found and sold netted \$9.26, as shown by auction sheet, dated ot. 21, 1944. This our was credited to the account of Hane OUE.
