husband indicates any shipment of anything to these people. On December 18, 1944, this office sold at suction contents of tub and boxes, lot of dishes, etc., lot of lineware, etc., box of tools, etc., cupboard, carpet and kitchenware, for the net sum of \$39.92 which was credited to the account of Yasugiro KUSUMI, husband of this woman. Since the file gives no indication of the contents of the various boxes and the auction sheet is rather vague, it is impossible to judge whether all the chattels belonging to these people have been accounted for.
