PERSONAL PROPERTY SUMMARY

March 6, 1946.

Re: Hara (Mrs. Yosugiro) KUSUMI, Reg. No. 09973

In her declaration to the Custodian on March 27, 1942, this woman declared 3 trunks of personal clothing, kitchenware, cutlery, china-ware, all at her former residence 2721 Bridge St., Victoria, B.C.

Articles found at this address were moved to the Willows and on July 28, 1942, this woman and her husband signed a confirming list of goods which we had stored. These goods were 8 cases, boxes and cartons, contents unknown, 2 trunks, contents unknown, 1 basket, contents unknown, 1 roll of carpet and 1 rug, both tied, boiler filled with household effects, 1 wardrobe and 1 watering can. Neither the file of this woman nor that of her husband indicates any shipment of anything to these people. On December 18, 1944, this office sold at auction contents of tub and boxes, lot of dishes, etc., lot of glassware, etc., box of tools, etc., cupboard, carpet and kitchenware, for the net sum of \$39.92 which was credited to the account of Yasugiro KUSUMI, husband of this woman. Since the file gives no indication of the contents of the various boxes and the auction sheet is rather vague, it is impossible to judge whether all the chattels belonging to these people have been accounted for.

This woman also declared one \$50.00 Victory Bond held at her home 2721 Bridge St., Victoria. In the absence of any evidence to the contrary we shall assume that this Victory Bond was taken away by Mrs. KUSUMI when she was vacated.

This file reveals no other property of any kind.
