

This man signed a declaration to the Custodian on April 9, 1942. He was evacuated on April 22, 1942.

He reported a fishing boat "Wakida" in custody. Our records show this boat was sold through this office and the net proceeds in the amount of \$204.05 were credited to the account of this man. We are today remitting this amount to him.

The account of this man was credited with the sum of \$10.35 received in full settlement of his claim for refund of expenses incurred at the time of the impounding of his vessel. This is being remitted to him today.

This file reveals no other property of any kind.

Funds from the sale of the vessel "Y.W." N.048-B have been frozen in this man's account.

This vessel carried Naval Control No. N.048-B. This number had been issued to Y. WAKIDA, of Nanaimo, for a vessel similar to the "Y.W."

This vessel was sold under gas-boat licence Nanaimo 3322. This number was incorrect.

Fishing Lic. 3322 (Salmon Gill-net) was issued in 1941 to William Herman. The number is too high to be anything other than Salmon-Gillnet. The "Y.W." was a cod-fish boat.

Yoshigusu WAKIDA has stated that he owned this boat, in fact he had lived on the boat up to the time she was seized. According to the records of Naval Service, the boat was surrendered by a man named WAKIDA.

If you consider this sufficient proof of ownership, will you please O.K. the memorandum to the Accounting Department.
