PERSONAL PROPERTY SUMMARY

Re: FURUKAWA, Haruo - Reg. No. 03014.

The above signed a declaration to the Custodian on April 9, 1946, and was evacuated on April 16, 1942.

PISHING

VESSEL: He was the owner of the vessel "H.F." which was sold to the B. C.
Packers Ltd. on March 23, 1942 for the net sum of \$850.00. Supervision costs amounted to \$8.50 and the balance, namely \$841.50
was remitted to H. Furukawa, on March 25, 1942.

MONEYS OWING:

He declared \$115.00 owing to him by Francis Millerd & Co., his employer. We wrote to Haruo FURAKAWA on August 28, 1944 asking him to advise us whether this was still owing. No reply was received and we presume that the claim was settled prior to evacuation.

WAR SAVINGS

CERTIFICATES: He declared \$5.00 in War Savings Certificates in his own possession. These were not brought under the control of the Custodian.

LIFE

INSURANCE: He declared a life insurance policy in the amount of \$1,000.00 (approximate) in his possession, with the Prudential Life Insurance Co. on October 22, 1946, the Prudential Insurance Co. advised us that Haruo EURUKAWA had requested the cash surrender value of his policy. We replied that the Custodian had no objection and requested only that we be forwarded a copy of their remittance letter for our records.

This file reveals no assets other than those mentioned above.
