GENERAL SUMMARY

July 5, 1946.

Re: Katsumi TATEISHI, Reg. No. 04384

This man signed a declaration to the Custodian on April 9, 1942. He was evacuated on April 15, 1942.

In his declaration he reported a bank account in the Royal Bank at Steveston with a balance of \$50.00 and a \$1,000.00 policy with the Manufacturers Life Insurance Co., and a \$5,000.00 policy in the Yorkshire Savings Trust, Vancouver. None of these came under the control of this office.

Information from the R.C.M.P. stated that this man was the owner of a truck and a car. However the Motor-Vehicle Branch of the B.C. Police informed us on May 16, 1944 that both these vehicles had been transferred to the J. W. Kelly Piano Co. Ltd., Vancouver on March 9, 1942.

The account of this man was credited with the sum of \$8.00 received as refund of B. C. Electric Railway Co. Ltd. security deposit for light. This amount is being remitted to TATEISHI today.


