The above, who made his declaration to the Custodian on April 9th, 1942, and was evacuated on April 21st, 1942, declared the following goods left at Wales Island Cannery, Naas River, B.C.

- 1 Spring net
- 1 row boat

The Canadian Fish Co. Ltd., who own this Cannery, sent us a statement of the account of the above, together with their cheque in the sum of \$63.10, being his credit balance with that Company. This statement includes the purchase of a spring net, a coho net and a skiff by the Company from the above for the total sum of \$172.50. He owed the Company the sum of \$109.40, leaving him a credit balance with the company of \$63.10, which sum, as previously stated, was remitted to this office and on December 1st, 1942, was sent to Ichimatsu MIYAWAKI.

This vessel was impounded. She was shown on the Naval List of Impounded Vessels as the "I.M. 678" owned by I MIYAWAKI.

She was released to the Canadian Fishing Company Ltd., licensed owners, from custody on April 8, 1942.

The "I.M." was shown on list of company-owned boats, supplied to the JFVDC by the Canadian Fishing Company, as being operated by I. MIYAWAKI, WALES ISLAND CANNERY.

The information given by the Canadian (678) Fishing Company and the licence number (Fishing) shown on the RCMP Information sheet would indicate that this is the vessel that was reported to the R.C.M.P. as being the property of Ichimatsu MIYAWAKI.

As Ichimatsu MIYAWAKI did not declare ownership when he registered with the Custodian, and did not report ownership to the JFVDC, it can be assumed that, if he had any interest in this vessel, he and the Canadian Fishing Company had settled this.

This vessel was in custody at New Westminster.

There was no claim for loss or damage to the vessel while in custody.
