





Dear Sir:

On several occasions we have asked for information as to your personal belongings left at 333 Ewen Avenue. When you declared these you stated that they were in your own custody but you failed to say what they were.

As we have stated before, all the personal effects found at the above mentioned address were removed and sold but it was found impossible to decide their ownership. To solve the problem we wrote to Mr. Y. Katakami, who formerly occupied 333 Ewen Avenue and asked him to contact you, and Mrs. S. Takeuchi, (all of you apparently owned effects left there,) to the end that you agree amongst yourselves as to the distribution of the money received from the sale of the effects.

This money is credited to Y. Katakami and it should be to the interest of all parties that this matter be settled, and we ask you therefore, to give this your attention.

Dear Sirs

We have written to you on numerous occasions in regard to the personal effects removed from 333 Eben Avenue and sold at auction. As there were three other persons besides yourself who declared they had left their effects at this address, it is not yet clear as to the ownership of these.

The storage at 333 Eben Avenue appears to have been a last minute affair as in no case did any person give the Custodian a list of their possessions and this office was therefore, quite in the dark as to what they were or to whom the goods belonged. Consequently, when our fieldmen removed the saleable effects they simply took what they found, and as you have already been advised, credited the account of Yuichi KATAKAMI, the registered householder, with the sales proceeds.

We are sending a copy of this letter to all those persons interested and would suggest that the funds representing the proceeds from chattels auctioned be left in Mr. KATAKAMI'S account until you decide between yourselves as to its distribution. To this end will you kindly sign in the place indicated on the attached slip and return this slip if agreeable.
