#### PERSONAL PROPERTY SUMMARY

#### Re: FURUKAWA, Shigio - Reg. No. 01618.

This Japanese signed a declaration to the Custodian on April 9, 1942 and was evacuated on June 29, 1942.

CHATTELS: He declared 1 bed at Sherman, B.C. and cooking utensils and dishes at 391 Powell St., Suite No. 12.

No bed marked with his name was found at Sherman, where the Great Northern Cannery was located; the few beds which were moved from there, however, were discarded as being valueless.

Nothing marked with his name was moved from 391 Powell Street. This was the Victory Rooms, operated by Katsutaro NAKASHIMADA, File 4667 and all the chattels stored by ten or twelve were moved to 154 West 5th Avenue in June 1943. Mr. Wills advises that 154 West 5th. was repeatedly ransacked and that nothing whatever remains belonging to the former tenants of 391 Powell Street.

The Japanese was advised that nothing belonging to him could be found and in the absence of any comments we presume that he had disposed of his chattels before being evacuated.

SPECIFIED ARTICLES:

Car - FURUKAWA was the owner of a 1934 Ford V-8 Coach which was sold for the sum of \$250.00. A lien held by the Industrial Acceptance Corporation, amounting to \$160.00 was paid on September 16, 1942 and discharge received. Expenses amounted to \$27.23 and the balance, namely \$62.77 remitted to Japanese on June 19, 1943.

Radio and Cameras - FURUXAWA surrendered 1 radio and 2 Cameras to the R.C.M.P. The radio was sold by Auction for the net sum of \$30.41 and the two cameras are at present stored at 604 East Cordova. As soon as the receipt is received from the Japanese the money will be remitted and cameras shipped. The Market 12.
