ENERAL SUMMARY

File No. 2397 Kichiji UNUSHIHARA, Dec'd. Reg.No. 10730

Kichiji URUSHIHARA died at Slocan on September 12, 1943. He is survived by his widow, Hatsue, file \$7230, who has now been repatriated to Japan. He had no children.

The only assets declared by the deceased were a 22 foot gas boat and 200 fathoms of sockeye net which he valued at \$20.00. The boat was sold for the sum of \$50.00 and the proceeds credited to the account of the deceased. The net was not found and was probably valueless.

The only claim filed against the deceased was for the sum of \$80.00 to cover funeral expenses paid by the B. C. Security Commission. On March 15, 1945, Custodian cheque for \$50.00, being total funds to the credit of the deceased, was forwarded to the B. C. Security Commission to apply on their claim. The widow was advised of the disposition of her husband's assets.

No assets and no liabilities, other than those mentioned above, appear on this file.

This summary is certified to be in accordance with information on file.
