Replying to copy of your letter of March 11th, addressed to the Gustodian of Alien Property, re goods belonging to the above we have located these articles stored in a supposed at 718 France Street.

These boxes are closely packed together. We were accompanied by an official of Lindsay's Cartage; he hauled out the front row but time did not permit nor was it fessible to pull out everything and put it back again. He gave a rough estimate of 500 pounds weight, and computed the shipping charges to Vancouver at around \$4.50. Lindsay's charges for cartage and some re-crating (many of the boxes are flimsy cartons) at \$3.50. Our charges for our services in connection with this matter will be \$2.000 If you desire them shipped let us know at once and we will arrange it, possibly at the time of shipping the Miwa goods.

The electric so ang-mechine was in the cupboard and will need orating.


