Hevertheless we received the sum of \$187.78 from the Phoenix Cannery of the A.B.C. Packing Co., being the proceeds from sale of fishing gear The account of the above was credited with this sum although he had worked for the Imperial Cannery, As there are two men with the name "K. NAKANO" on our files, we wrote to our Stevesten agent, "r. C.C. Robinson on Nov. 28/42 to find out which one of these men should be credited with this money.
