All barber equipment and personal effects, as shown in the inventory attached hereto, are the joint property of Chojiro Sumida, H. Sumida and T. Ono. The inventory has been checked and is correct in detail, but the prices given are excessive. In a sale, the inventory would not produce any more than one-half of the figures given. On evacuation, it is the wish of H. Sumida and T. Ono, to store all of the above equipment and effects, with the exception of one trunk containing personal goods and one Sewing Machine, which they hope to take with them.

#### RECOMMEN DATION

I would recommend that on evacuation of H. Sumida and T. Ono, their wishes be followed and that the barber shop equipment and personal effects, other than what is taken with them, be stored for the duration.
