On March 24, 1942 he signed a declaration to the Custodian stating that he owned one \$50.00 Victory Bond and \$50.00 in War Savings Certificates which were in his own possession at that time. These did not come under the control of the Custodian. On August 14, 1942 a cheque for \$380.00 was received from J.S. Greer of Prince Rupert. This sum was the balance due SUYEHIRO from the sale price of an engine sold on his behalf by Mr. Greer for the sum of \$500.00 after the deduction of \$125.00 due Mr. Greer from SUYEHIRO. On October 9, 1942 and November 23, 1942, remittances totalling \$150.00 were made to SUYENIRO. In August 1943, \$25.00 was remitted to his wife. In September 1943, \$5.45 was paid to the B.C. Security Commission and in October 1942, we paid at his request a claim filed against him, This leaves a credit balance in his account at this date of \$181.55. The vessel described in the Vessel Summary was sold privately and we have no information other than that given in the summary. This file reveals no other property of any kind.
