Rokuso Suzuki died in Ontario on February 8, 1947. He is survived by his widow, Tori, file #389, also resident in Ontario.

The deceased declared kitchen utensils and tools left in his house at B. C. Packers Cannery, Rivers Inlet, B. C.; an account in the Royal Bank, East End Branch; and a Pacific Mutual Benefit Membership certificate #3480. It is presumed that the goods left at the Cannery were forwarded to Suzuki by the cannery as no further mention is made of them. From a telephone conversation with the Royal Bank, East End Branch, it is learned that the bank account declared was closed out and from a telephone conversation with the Pacific Mutual Benefit Association it was learned that the death claim under Suzuki's membership certificate in that Association was paid in full in April 1947.
