

TAKAMATSU informed us in January, 1944, that this bill was incurred about seventeen or eighteen years prior to that time and that he had paid \$120.00 to the doctor on a bill of \$150.00. He stated that the doctor had informed him he would cancel the balance. This information was given to the creditor who has not written to this office again in regard to this matter. If this claim was incurred twenty years ago it would now be outlawed, and no further action has been taken by this office.

This file reveals no further liabilities.

PERSONAL PROPERTY SUMMARY

Re: Sadakichi TAKAMATSU, Reg. No. 11051

In his declaration of March 24, 1942, to the Custodian, this man who was evacuated on August 31, 1942, declared the following in his warehouse at Inverness Cannery, Skeena, B.C.: 12 sacks of rice, 2 trunks, 2 beds and mattresses, 1 Singer treadle sewing machine, 7 packages of kitchen utensils, 1 Cohoe net and 1 Spring net.

On June 15, 1942, J. H. Todd & Sons purchased from this man 2 Cohoe nets and 1 Spring net at a total price of \$95.00. The second Cohoe net we believe to be the same as that declared by his son, Kazuo TAKAMATSU, file 2522. This sum of \$95.00 was credited to the account of Sadakichi TAKAMATSU and has since been remitted to him. As the family appears to be all living together the fact that the father was paid the money for the Cohoe net declared by his son does not appear to be important.

On June 23, 1942, we received from J. H. Todd & Sons \$51.00 in payment of 8½ cords of wood, \$3.00 in payment of a baby carriage and \$160.00 in payment of two sets of drums and fittings purchased from Sadakichi TAKAMATSU. These funds were handed to TAKAMATSU in June, 1942. A quantity of household effects, tools and foodstuffs were shipped from Prince Rupert in July, 1942 to TAKAMATSU. Another shipment was made in May. These shipments took care of his effects left in Inverness Cannery.

He also declared a Singer electric sewing machine, stored in Vancouver. On August 7, 1942, TAKAMATSU reported to Mr. George B. Spain of this office, that this sewing machine was in his possession at Hastings Park.

On April 21, 1943, at the request of Mr. Takanosuke OMORI we credited the account of TAKAMATSU with the sum of \$35.00 in payment of work done by him. These funds were remitted to TAKAMATSU on May 31, 1943. On April 11, 1945, the account of Sadakichi TAKAMATSU was credited with \$50.25 in full settlement of claim for expenses incurred in connection with the impounding of the vessel "S.T.". As he informed us on February 11, 1946, that his son, Sadao TAKAMATSU, file 2526, was entitled to this refund this money is being transferred to the account of his son today.

Two Hawk-eye cameras, which the Royal Canadian Mounted Police reported were surrendered by Sadakichi TAKAMATSU, are in the Custodian warehouse, 604 Cordova St., Vancouver.

According to the records of the Japanese Fishing Vessel Disposal Committee, the vessel "S.T.", Prince Rupert licence 508, was sold for the total sum of \$350.00 in March, 1942, and the net proceeds of this sale, \$344.00 were paid to TAKAMATSU on April 1, 1942.

This file reveals no other property of any kind.

As requested by you in your letter of February 11th, we have transferred to the account of your son, Sadao TAKAMATSU, the sum of \$50.25 which had been credited to your account in full settlement of the claim filed by you with the Japanese Fishing Vessels Disposal Committee for reimbursement of expenses incurred at the time of the impounding of the vessel "S.T."

Your file shows that in June, 1942, this office received from J. H. Todd & Sons a cheque for \$309.00, in payment of 8 1/2 cords of wood, a baby carriage, two sets of drums and fittings, two Cohoe nets and a Spring net. This cheque was handed to you at Hastings Park in June, 1942.

According to our records, the remainder of your chattels were shipped to you with the exception of two cameras which had been surrendered to the Royal Canadian Mounted Police. These cameras are in Custodian warehouse in Vancouver and will be returned to you if you will send us the receipt given to you at the time the cameras were surrendered, and also send us the sum of 25 cents to cover shipping costs.

The records of the Japanese Fishing Vessels Disposal Committee show that the vessel "S.T." was sold by you in March, 1942, and the net proceeds of the sale in the amount of \$344.00 paid to you on April 1, 1942.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian and in order that you may confirm this and inform us of your wishes in regard to the two cameras, we enclose a stamped addressed envelope for your convenience in replying.





As regards the Sewing Machines, the treadle type machine is in his possession at Hastings Park. He states that the Electric Sewing Machine is still in storage at 137 Hastings Street, Vancouver, B. C., in the name of Mrs. Iwata. ✓

Mr. Takamatsu asserts that the Inverness Cannery still owes him money, but was unable to clarify this issue. (*)

The discrepancy in stock lists (i.e. 1 tin household goods) may be eliminated, this he states is represented on the list as 1 Bath Boiler, apparently a double entry.


When my boys were under Dr. Hankinson's care about 17 or 18

When paying these bills I was \$30 short and Dr. Hankinson ad-
vised me to pay the hospital bill first altho there would be a charge
of \$30 to him. This, he said he would strike off his books. I have
no written note or proof from the Doctor to certify that he had cancelled
the \$30 from my account except his word.

We have lived at Inverness Cannery from that time till Evacuation
and during my stay there we have not once received any bill from him and had
thought everything was settled.

However, if we had known of this we could have been able to pay be-
fore evacuation, but at present we are unable to do so. If it has been my
misunderstanding that he would cancel the debt I will try to pay it as soon
as I am able to.
