PERSONAL PROPERTY SUMMARY June 14, 1946. File No 2536 Re: Fumi (Mrs. Heitaro) TAKEDA, Reg. No. 07531 This woman signed a declaration to the Custodian on March 28, 1942. She was evacuated on September 9, 1942. In her declaration she reported 19 pieces of foodstuffs and household effects. A notation from H. G. Hinton, Victoria, states that amateress was found but not declared and a chair was declared but not found. On May 22, 1942, 17 pieces were shipped to Mrs. TAKEDA. On July 25, 1942, Mr. Spain at Hastings Park wrote that this lady had reported that 2 chairs were left. These chairs were never found. The 2 remaining pieces declared were stored with Mr. Burnip at Port Alberni but Mr. Burnip advised us verbally in this office on June 12, 1946, that these had been discarded as valueless.
