GENERAL SUMMARY

August 13, 1946.

Re: KAZUO TAKESHITA, Reg. No. 60118

This man signed a declaration to the Custodian on March 23, 1942. He was evacuated on September 26, 1942.

In his declaration he reported a bank account with the Bank of Montreal, Port Alberni with a balance of \$890.00, and a \$1,000.00 life insurance policy with the Nomanah Life Assurance Co. These items did not come under the control of this office.

The R.C.R.P. handed to this office 2 Brownie cameras surrendered by this man. These were mailed to TAKESHITA on February 22, 1945, receipt being on file. He remitted \$1.00 to cover cost of mailing and as mailing charges amounted to only 26 cents we remitted 74 cents to TAKESHITA.

This file reveals no other property of any kind.
