PERSONAL PROPERTY SUMMARY Pile No. 2560 March 22, 1946. Ret Shizeko UVESUGI, (Mrs. Takaji), Reg. No. 03029 This woman signed a declaration to the Custodian on April 4, 1942. She was evacuated from the protected area on April 28, 1942. Herdeclaration stated that she owned no property of any kind whatsoever in the protected area. A radio and camera were surrendered to the Police by Mrs. UYESUGI. The camera was released to the B.C. Security Commission on September 20, 1943, for shipment to the owner. The radio was sold by the Custodian for the net sum of \$31.41. This sum was remitted to Mrs. UYESUGI on January 4, 1945. This file reveals correspondence with the Metropolitan Life Insurance Co. in regard to policies on the lives of Robert, Douglas and Edward, young sons of this woman. These life insurance policies did not come under the control of this office. This file reveals no other property. The household chattels belonging to this woman and her husband are dealt with on the file of her husband, file 2090.
